DEFINITION OF TERMS IN STATE FACT SHEET

Child Care (also called early care and education, early childhood education, care and education, and early learning):

Experiences and relationships that enhance young children's development and learning. Learning can take place in all settings where children are being cared for, and the outcomes of the learning depend on a number of factors, including quality of the child/parent or child/caregiver relationship, teacher/caregiver preparation, a stimulating but not stressful environment, good nutrition, health care, and special needs interventions.

Child Care Center: An early care and education facility that is licensed by the state, and operates under a proprietary or not-for-profit status, independently, or as a part of a large chain of facilities or a faith-based organization.

Accreditation: A voluntary program that establishes national or state standards for early childhood education programs exceeding basic state licensing regulations. Accreditation is outside of the state or federal regulatory system.

Family Child Care Homes: Child care offered in a caregiver/teacher's own home and, depending on the state's licensing regulations, may be licensed or exempt from licensing.

Spaces/Slots: Space or slot available for a child at a child care facility (center, home or school-age program).

Request: Parents, guardians or other adults in charge of children contacting the agency to ask for/request a referral for child care services.

Infant/Toddler: Infants are children up to 18 months (1^{1/2} years) old. Toddlers are children between the ages of 18 months (1^{1/2} years) and 36 months (3 years).

Pre-School Age: Children between the ages of 3 and 5 years, who are not yet in kindergarten are considered to be of pre-school age.

School Age: Children, who have started school, normally 6 years and older, are considered to be school age.

Special Needs: Children who have a physical or mental disability and/or children with a chronic illness.

Full-Time Care: Use your state's definition of what constitutes full-time care.

Part-Time Care: Use your state's definition of what constitutes part-time care.

Before and After School Care (also called School-Age Care and Out-of School Time Care): Daily programming and peer group activities with adult supervision for school-age children (kindergarten through age 13) offered before and after the regular school day and during holidays and vacations. The activities are provided in family child care homes and centers, and may be in other settings that are exempt from licensing, such as schools and faith-based organizations.

Non-Traditional Hour Care: Care outside the traditional 8am to 5pm, Monday through Friday work week. This type of care includes intermittent care, evenings, weekends, care for mildly ill-children, emergency care, seasonal care, and rotating shift care.

Provider: A person or program that provides early care and education for children. Providers include nannies, license-exempt caregivers, care and education teachers, child care centers, family child care homes, Head Start, and pre-k programs.

Rural: Areas with population of less than 50,000. This is how the U.S. Census Bureau defines a rural area.

Urban: Built-up area with population of 50,000 or more. It comprises of one or more *central places* and adjacent densely settled surrounding areas, known as *urban fringe*. This is how the U.S. Census Bureau defines an urban area.
